Job Overview

You will be responsible to the Senior Development Trainer (SDT) and will support the effective and safe delivery of Venture Trust programmes. You will be required to work as a team, to lead and coach the participants, supervising them throughout their wilderness journey. You will also conduct one-to-one sessions, focusing on the wellbeing of the participant and their personal development, allowing them to develop transferable skills for when they are back in their community. You will be responsible for the production of the relevant plans and reports, as well as for the maintenance, upkeep and storage of all associated equipment. You will work closely with the SDT to ensure that programmes are equipped effectively, operated safely, and in accordance with Venture Trust Operational Guidelines. You will also be expected to ensure that you adhere to all appropriate risk assessments and Health and Safety regulations.





Detailed responsibilities

Deliver and resource wilderness journeys/activities

- Plan and prepare sessions/activities for participants.
- Deliver safe and effective mutually agreed activities in accordance with aims and objectives of the programme, including group and one-to-one support sessions.
- Identify activities and resources in wilderness areas of operation.
- Work towards developed and sustained peer support among the participants during activities/expeditions.
- Keep records as appropriate regarding each participant within set timeline.

Health and Safety and maintenance

- Ensure the welfare and safety of participants.
- Be responsible for health and safety and conversant with current legislation relevant to the safe running of activities/programmes.
- Assist SDT and Stores-person in vehicle monitoring, and care and maintenance of equipment and facilities.
- Assist with the regular checking and recording of equipment use, in compliance with AALS and other relevant legislation.
- Undertake maintenance of equipment, facilities, and records as necessary

Relationships and communications

- Work closely together with colleagues in the Outreach Team to ensure effective communication of the development needs of the participants, and in resourcing and delivering appropriate wilderness and comunnity-based activities.
- Liaise with Venture Trust staff to ensure effective communication and coherence of programme phases.
- Deputise for the Senior Development Trainer when necessary.

Other:

- Undertake any training and professional development as and when required.
- Undertake any other reasonable duties as may be determined by your line manager.

- Ability to set appropriate professional standards for self and others.
- Ability to operate recording systems to keep track of maintenance schedules.
- Experience of checking, maintaining and auditing vehicles, trailers and outdoors equipment.
